

Welcome to Cineplex Entertainment LP's "Win a trip to FanExpo" ("Contest").

By entering this Contest, you acknowledge that you have read, understood and accept the terms and conditions below.

**Sponsor:** Cineplex Entertainment LP ("Cineplex") is the sole sponsor ("Sponsor") of this Contest and Cineplex is responsible for conducting and administering this Contest.

## **1. How to Enter:**

No purchase is necessary. Contest begins at 5:00 PM ET January 19, 2016 and ends at 11:59 PM ET on February 11, 2016 ("Contest Period"). SCENE members who purchase tickets to any film at The Great Digital Film Festival 2016, at any Cineplex Entertainment theatre (excluding Quebec), online at Cineplex.com or on their mobile phone through the Cineplex mobile website will be automatically entered for a chance to win. Every ticket purchased qualifies as an entry into the contest. Entrants must enter or provide their SCENE membership number at the time the ticket is purchased. An individual who is not a SCENE member may enroll at: <https://www.scene.ca/enrollment.aspx>. Enrollment in the SCENE program is free of charge.

Participants may also enter the Contest by submitting a postcard with their name, address, phone number (with area code), SCENE membership number and email address and mail it with sufficient postage to 1303 Yonge St, Toronto, Ontario M4T 2Y9. All mail-in entries must be postmarked during the Contest Period and received no later than February 16, 2016. Sponsor is not responsible for entries delayed, lost stolen or damaged in the mail. Mechanically reproduced entries will not be accepted. Multiple postcards mailed together in a single envelope will be void and not entered into the Contest.

The odds of winning depend on the total number of eligible entries received during the Contest Period.

## **2. Prizes:**

### **a. Grand Prize:**

There is a total of (1) one Grand Prize available to be won. The Grand Prize consists of:

- round trip economy airfare for two (2) people (including the selected winner) to Toronto, Ontario from the major Canadian international airport closest to the winner's place of residence\*
- hotel accommodation for two (2) people for five (5) days and four (4) nights based on double occupancy (hotel selected by Sponsor in their sole discretion)
- Two (2) 4-day passes to the FanExpo™ Canada which takes place September 1-4, 2016

Trip must be taken between September 1-5, 2016

\* If the winner lives close enough to Toronto that airfare would not be reasonably required (as determined by Sponsor) limo transportation from the winner's place of residence to and from the hotel will be provided.

Approximate Retail Value ("ARV"): \$2,800, based on sample Vancouver departure. Actual value of Grand Prize will vary depending upon point of departure and fluctuation in hotel and airfare rates and the selected Grand Prize winner will not be entitled to any difference between the actual value of the Grand Prize and the ARV. Accommodations and flight times are subject to availability. The details of each component of the Grand Prize, including, without limitation, choice of airline and accommodation, are as determined by the Sponsor in its sole discretion. No change in travelling arrangements can be

made once the booking has been confirmed. The Sponsor is not responsible if any scheduled event, including the FanExpo event (the "Event"), is delayed, postponed or cancelled for any reason and the winner will not be reimbursed for tickets or any additional costs, including costs of accommodation. #### ***Grand Prize:***

The Sponsor will attempt to contact the potential Grand Prize winner at the telephone or email contact information associated with the SCENE membership number provided at the time of entry. If the potential Grand Prize winner cannot be contacted, or does not reply to the contact by 5:00 PM EST on February 22nd, 2016 then the selected potential Grand Prize winner shall forfeit all right and entitlement to the Grand Prize and the Sponsor shall have the right to choose another entrant from the remaining eligible entries.
