**GALAXY CINEMAS BARRIE
HOSTS GALA FUNDRAISER
TO CELEBRATE ITS NEW NAME**

The newly renovated Galaxy Cinemas Barrie, located at 72 Commerce Park Drive features 12 auditoriums, all equipped with full digital surround sound and stadium-style seating. The concession offerings include the traditional "must have" movie-going food choices of popcorn, candy and soft drinks, and now also features *Yogun Fruz* frozen yoghurts, smoothies and premium ice creams.
